

Samuel Furrer holds a PhD from the University of Zurich.

Hazel Henderson, D.Sc.Hon., FRSA, is a futurist, evolutionary economist and author of nine books including the Axiom and Nautilus award-winning book Ethical Markets: Growing the Green Economy (2006). The founder of Ethical Markets Media, LLC, and creator of its TV series, her editorials are syndicated by InterPress Service, with articles appearing in journals such as Harvard Business Review, New York Times, Christian Science Monitor and many international ones. She leads the Transforming Finance initiative, created the Green Transition Scoreboard®, co-developed the GDP alternative the Calvert-Henderson Quality of Life Indicators and co-organized the Beyond GDP conference for the European Commission, funding two Beyond GDP surveys, finding strong support worldwide for ESG metrics in national accounting, now tracked by the OECD. She is an Honorary Member of the Club of Rome and shared the 1996 Global Citizen Award with Nobelist A. Perez Esquivel of Argentina.



Michael Pawlyn Exploration Architecture, London/UK, Director

Michael Pawlyn established Exploration in 2007 to focus exclusively on biomimicry. In 2008 Exploration was short-listed for the Young Architect of the Year Award and the internationally renowned Buckminster Fuller Challenge. Prior to setting up the company Michael Pawlyn worked with Grimshaw for ten years and was central to the team that radically re-invented horticultural architecture for the Eden Project. He was responsible for leading the design of the Warm Temperate and Humid Tropics Biomes and the subsequent phases that included proposals for a third Biome for plants from dry tropical regions. He initiated and developed the Grimshaw environmental management system. In 2011, he became one of only a small handful of architects to have a talk posted on TED.com.

Lynn Reaser

Chief Economist, Fermanian Business & Economic Institute/FBEI, Point Loma Nazarene University, San Diego/California

The FBEI Institute engages in economic analysis, modeling, and forecasting with practical and actionable recommendations for corporations, non-profit organizations, and government agencies.
